



Terms and Conditions for AI Health World Summit 2025 Poster Competition

Eligibility:

- 1.1 The Scientific Poster Competition (hereinafter referred to as "the Competition") is open to individuals aged 18 years or older at the time of entry.
- 1.2 The Competition is open to participants from all countries.
- 1.3 Each participant may submit more than one entry.

Entry Submission:

- 2.1 To enter the Competition, participants must submit an abstract based on their original research work.
- 2.2 The abstract should be in English and prepared according to the guidelines provided by the organising committee.
- 2.3 Submissions must be made through the official submission platform provided by the organising committee.
- 2.4 Participants are responsible for ensuring that their entries are complete, accurate, and comply with all applicable laws and regulations.
- 2.5 Late or incomplete submissions will not be accepted.

Intellectual Property Rights:

- 3.1 Participants retain full ownership and copyright of their poster submissions.
- 3.2 By entering the Competition, participants grant the organising committee a non-exclusive, royalty-free license to use, reproduce, distribute, and display their posters for promotional purposes related to the Competition.
- 3.3 The organising committee acknowledges and respects the intellectual property rights of the participants and will not use the posters for any other purposes without prior consent.

Judging and Selection:

- 4.1 The posters will be judged based on scientific merit, clarity, visual appeal, and adherence to the competition theme.
- 4.2 The judging panel will be composed of experts in the relevant scientific field, appointed by the organising committee.
- 4.3 The decision of the judging panel will be final and binding.
- 4.4 The organising committee reserves the right to disqualify any entry that violates these terms and conditions or exhibits plagiarism or unethical practices.

Prizes:

- 5.1 The organising committee will determine the prizes and awards for the competition.
- 5.2 The prizes are non-transferable.
- 5.3 Winners will be notified by email or through the official competition website.
- 5.4 The organising committee reserves the right to substitute prizes with items of equal or greater value if necessary.

Publicity:

- 6.1 By participating in the Competition, participants agree that their names, affiliations, and a brief description of their research may be used for promotional purposes by the organising committee without further compensation.
- 6.2 The organising committee will seek participants' consent before using any personal information beyond the scope mentioned in these terms and conditions.

Disqualification and Termination:

- 7.1 The organising committee reserves the right to disqualify any participant who breaches these terms and conditions.
- 7.3 Shortlisted abstracts are required to purchase a ticket for entry to the event in order to present their posters. Failure to obtain a ticket by the specified deadline will result in disqualification from the competition.
- 7.2 The organising committee may terminate or suspend the Competition at any time due to unforeseen circumstances or force majeure events beyond its control.

Limitation of Liability:

- 8.1 Participants agree to release, discharge, and hold harmless the organising committee, sponsors, and their respective officers, directors, employees, and agents from any and all claims, liabilities, losses, damages, costs, and expenses arising out of or related to their participation in the Competition.
- 8.2 The organising committee will not be liable for any indirect, incidental, consequential, or punitive damages arising from the Competition.

Governing Law and Jurisdiction:

- 9.1 These terms and conditions will be governed by and construed in accordance in accordance with the laws of the Republic of Singapore, and you agree to submit to the non-exclusive jurisdiction of the courts of Singapore.
